Grawemeyer Award for Music Composition 2010



The University of Louisville School of Music is pleased to announce the University of Louisville Grawemeyer Award for Music Composition 2010. The University will offer an international prize in recognition of outstanding achievement by a living composer in a large musical genre: choral, orchestral, chamber, electronic, song-cycle, dance, opera, musical theater, extended solo work, etc. The award will be granted for a work premiered during the five-year period between 1 January 2004 and 31 December 2008. The amount of the award to the composer will be two hundred thousand dollars (\$200,000.00).

The Grawemeyer Music Award Committee invites the submission of scores by outstanding composers throughout the world and has established the following rules and procedures for its selection of the winning work:

1. Each entry for the Grawemeyer Music Award must be nominated by a professional musical organization or individual (performer or performing group, conductor, critic, publisher, or head of a professional music school or department). A composer may not submit his or her own work. No more than one work of any composer may be submitted, and entries from previous winners of this award will not be considered.
2. Each entry must include the following:
 - One bound copy of the full score. (For works with non-English text, it is recommended that an English translation or English synopsis be submitted.)
 - One excellent quality recording of the *complete* work. Send *only* audio compact disc(s). Synthesized performances of acoustic works will not be considered. If possible, please provide separate tracks for each movement of multi-movement works.
Do not include spoken commentary such as radio interviews or conductor's remarks.
 - Documentation of the premier public performance of the work between 1/1/04 and 12/31/08: printed program, reviews, etc. A radio broadcast or sound recording does not constitute a premier. Works may be resubmitted during the period of eligibility. In the case of resubmission, entrants need not resubmit scores or recordings as these will be retrieved from the Grawemeyer Collection; however, all other required materials must be resubmitted and the handling fee paid.
 - Program notes in English
 - Supporting letter in English from the nominator of the entry, which must state nominator's relation to the submitted work and nominator's belief in the outstanding qualities of the work
 - Composer's photograph
 - Composer's biography in English, which should briefly outline the composer's total achievement and recognition
 - Completed, signed entry form in English
 - Non-refundable handling fee of forty dollars (\$40.00 in U.S. currency). Payment may be made by check drawn on a U.S. bank or by international money order, payable to the Grawemeyer Music Award Committee. Contact grawmus@louisville.edu for instructions on payment via credit card (no bank or wire transfers, please).
 - All materials, including the handling fee, must be labelled with the name of the entrant.
3. After an initial screening, the Grawemeyer Music Award Committee will appoint a jury of three internationally recognized music professionals: normally a composer, a conductor and a critic. Each juror will select, from the qualifying scores, up to three works they deem worthy of the Award. These selected works are then submitted anonymously to the Final Committee to be judged by listening only. The Final Committee will then recommend one of these works to the President of the University of Louisville. Upon the recommendation of the President, the Board of Trustees of the University of Louisville will grant the Award.
4. Completed entries for the Grawemeyer Award must reach the University of Louisville by January 12, 2009. The Grawemeyer Award Committee will acknowledge receipt of all entries by email only. Please allow a month after the deadline for such notification. **Late or incomplete entries will not be considered.**

6. Announcement will be made in December, 2009 and the award will be made during the first week in March, 2010. Composers and nominators will be notified of the winner by email on or about the date of the public announcement.
7. The University of Louisville will retain all entered scores and recorded materials for inclusion in the Grawemeyer Collection of New Music, a part of the Library of the School of Music.
8. The prize will be paid in five annual installments of forty thousand dollars (\$40,000.00). However, no payment will be made to the estate or heirs of a deceased composer.

Entry Agreement and Release

The undersigned Entrant(s), in submitting the nominated work, including any translations or abstracts ("Work") for the Grawemeyer Award in Music Composition ("Award"), hereby freely acknowledges the following conditions:

1. Entrant shall abide by the rules and procedures of the Award as established by the University of Louisville.
2. Entrant shall abide by the decision of the Grawemeyer Award Committee and the University of Louisville, and the decision shall be accepted as final by Entrant.
3. Entrant shall jointly and severally indemnify and hold harmless the University of Louisville and its trustees, officers, employees or agents, including the Grawemeyer Award Committee members, from the cost of any legal proceeding, claim or other loss sustained in connection with any dispute as to any authority over ownership or rights of the Entrant(s) in the Work.
4. Entrant shall participate, as appropriate, and cooperate in the production of any documentary film or other public relations or publicity matters related to the Award, including the execution of any necessary releases and/or authorizations.
5. Entrant hereby grants permanent permission for the University of Louisville to use the title and excerpts from the Work and any media depicting his/her receipt and acceptance of the Award for library and archival purposes, and for the purpose of promoting the Grawemeyer Awards and their affiliation with the University of Louisville. The term "media" is understood to include, but not be limited to, audio and visual images and/or recordings of any format which depict the Entrant's visit to the campus of the University of Louisville, the Awards presentation itself and any comments made by the Entrant as part of the campus visit and the Awards festivities.
6. Entrant shall grant or cause to be granted, at no cost to the University, by the owner or agent of copyright to the Work, the necessary licenses for use or performance of suitable portions of the Work in a documentary film about the Award to be made by or for the University of Louisville and to be used in promoting the Grawemeyer Awards and their affiliation with the University of Louisville. Entrants must obtain permission from such owners, or agents of copyright before entering the Work.
7. Entrant agrees that, if the submitted Work wins the Award, all future performances of the work will be accompanied by the following statement in the printed program: "Winner of the University of Louisville Grawemeyer Award for Music Composition" and that future published editions and/or recordings of the work will bear the same statement.
8. All physical materials submitted become the property of the University of Louisville and all entered scores and recorded materials will be included in the Grawemeyer Collection of New Music, a part of the Library of the School of Music.
9. Entrant agrees to accept responsibility of all shipping and/or customs charges incurred (letter class air mail is suggested for foreign shipments as this normally avoids customs charges).
10. The winner of the Award will be announced after December 1st, 2009. The winner will be expected to come to Louisville during the following spring to make a formal presentation based on the winning idea and to receive the Award. This trip to Louisville is mandatory and failure to fulfill this requirement will result in forfeiture of the Award and the associated cash prize. During the week of the formal presentation, March 4, 2010, the winning composer shall be present on the UofL Campus for at least five school days to present the formal public lecture, meet with and tutor student composers, give master classes, seminars, presentations of their music, etc.; and the winning composer further agrees to return to the University, at school expense but without further recompense, for one additional period of five school days during the three school years following the awards ceremony to engage in similar activities.
11. Entrant agrees and accepts that, consistent with the intent of H. Charles Grawemeyer, the Award will not be given posthumously. The Entrant must be living in order to receive the Award and must participate in the Award festivities referenced above in order to receive the Award and the associated cash prize. If the nominated Work was composed by multiple composers, one or more of whom is deceased, only the living composers are eligible to receive the Award and the associated cash prize. The first installment of the cash prize will be paid at the Award festivities.
12. Entrant agrees and accepts that the cash prize associated with the Award will be paid in five annual installments of forty thousand dollars (\$40,000). The installment payments will cease upon the death of the recipient. Winning the Award does not create any property rights in the cash prize for the recipient's heirs or estate. In the event that the Award is given to multiple recipients (such as co-composers), there is only one cash prize associated with the Award and said cash prize will be divided evenly amongst the recipients. If a co-composer dies before the final installment is paid, payments to that co-composer will cease and the full amount of the remaining installments will be divided evenly between the still-living co-composers.
